

Resolution No. R4-2-26

The Village Board of the Village of Ashwaubenon does hereby resolve that this Resolution shall amend Resolution No. R8-1-19; that said Resolution R8-1-19 shall be void and that the following shall be the Bond Schedule to be used in the Municipal Court of the Village of Ashwaubenon for non-traffic violations.

It is further resolved that, if at any time any questions arise on the Bond Schedule, the Municipal Judge for the Village of Ashwaubenon shall be contacted and only the Judge shall have authority to release someone without bond or on a signature bond.

The amended Bond Schedule for the Village of Ashwaubenon, non-traffic violations, shall be as follows:
