**ORDINANCE NO. O3-1-24**

**AN ORDINANCE REPEALING AND RECREATING SECTION 22-5-123(D)(1), OF CHAPTER 22, UTILITIES, ARTICLE 5, SEWER SERVICE, RELATING TO AMOUNT OF USER CHARGES, VILLAGE OF ASHWAUBENON MUNICIPAL CODE**

**THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON DOES ORDAIN THAT SECTION 22-5-123(D)(1) BE REPEALED AND RECREATED TO READ AS FOLLOWS:**

**SECTION 1. SEC. 22-5-123 Wastewater Treatment Service Charges**

(D) *Amount of User Charges.*

(1) *User Rate Schedule*

The amount of user charges shall be based on the formula calculating the rates against charges to the sewer user for the operation, maintenance, and replacement costs for collection and treatment system. The Village Board shall review the local sewer charge rates on an as needed basis and revise the sewer charge rates as necessary to ensure the system generates sufficient revenues to pay the costs of operation, maintenance, and replacement. The sewer charge rate shall be identified in the Village Fee Schedule and amended by resolution as such time the Village Board may deem appropriate.

**SECTION 2.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect upon its adoption and publication.

This ordinance was adopted by the Village of Ashwaubenon Board of Trustees on the 26<sup>th</sup> day of March 2024.
