**ORDINANCE NO. O4-2-24**

**AN ORDINANCE AMENDING SECTIONS 6-7-373 AND 6-7-374, RELATING TO THE LICENSING OF CIGARETTE AND TOBACCO PRODUCTS IN THE VILLAGE OF ASHWAUBENON MUNICIPAL CODE**

**THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON DOES ORDAIN THAT CHAPTER 6, BUSINESSES, ARTICLE 7, CIGARETTE AND TOBACCO PRODUCTS RETAILERS, BE AMENDED TO READ AS FOLLOWS:**

**SECTION 1. Section 6-7-373 BE AMENDED TO READ AS FOLLOWS:**

No person shall sell cigarettes, electronic vaping devices, or tobacco products in the village without first obtaining a license from the village clerk. The provisions of Wis. Stat. § 134.65 are hereby adopted and made a part of this article by reference.

**SECTION 2. Section 6-7-374 BE AMENDED TO READ AS FOLLOWS:**

The cigarette retailer's license fee shall be on file in the office of the clerk which shall be paid to the village before the license is issued. This license fee shall be applicable to all license applications for the licensing period beginning July 1.

**SECTION 3.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 4.** This ordinance shall take effect upon its adoption and publication.

This ordinance was adopted by the Village of Ashwaubenon Board of Trustees on the 23rd day of April 2024.
