### Fee: Temporary Signs: \$30

Permanent Signs: \$1 per sq. ft. with a minimum fee of \$40

Electrical Permit (if applicable): \$50

## General Requirements:

- 1. Setbacks:
  - a. No part of any permanent freestanding sign or sign support structure shall be closer than <u>3 feet</u> to any property line.
  - b. No permanent freestanding sign shall be located closer than <u>30 feet</u> to an abutting R-1, R-2, or RE zoned parcel.
  - c. Temporary signs shall be posted on private property and shall not encroach upon any right of way.
  - d. No sign shall be permitted in the vision triangle area Ordinance Sec. 5-8-761
- 2. Sign Zone Designation (different than property zoning): Map can be found <u>here</u>
- 3. <u>Multi-tenant buildings</u> are permitted one wall, canopy, or awning sign up to 60 sq. ft. per tenant. End tenants, and tenant spaces where customer parking is to the rear of the building, are allowed up to two wall, canopy, or awning signs, up to 60 sq. ft. each, one per wall face.
- 4. **This is not an all-inclusive list of requirements**. Please reference Village Ordinance Section 17-6-200 for more details.

### **Permit Requirements:**

The following must be provided to obtain a permit for a sign:

- 1. Site plan showing the location of the sign on the property in relation to the property lines and any other structures on site.
- 2. A scaled drawing of the proposed sign and construction plans showing all dimensions (height, width, depth, etc.), materials, and landscaping
- 3. Samples of materials and replications of the exact colors proposed to be used for all sign elements including structural supports. This may be accomplished through submittal of a color rendering of the site and proposed signage.
- 4. Photographs showing the existing building(s) and sign(s), if applicable
- 5. Completed sign permit application

### **Required Inspections:**

- 1. Footing/Foundation, if applicable, prior to pouring concrete
- 2. Rough Electrical, if applicable, prior to covering the electrical work
- 3. Final, when sign is complete
