**ORDINANCE NO. 01-03-25**

**AN ORDINANCE AMENDING CHAPTER 7, TRAFFIC AND VEHICLES, ARTICLE 7:  
BICYCLES, MOTORBIKES AND SIMILAR VEHICLES.**

**THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON DOES ORDAIN THAT SECTION 7-239 REGULATION OF MOTORIZED BICYCLES, ELECTRIC PERSONAL ASSISTIVE DEVICES, ALL TERRAIN VEHICLES, AND OTHER VEHICLES BE AMENDED TO READ AS FOLLOWS:**

- (A) No person shall operate or ride upon any Motor-bicycle, Motorcycle, Moped, Electric Personal Assistive Mobility Device, All-Terrain or Utility Vehicle, Snowmobile, Commercial Quadricycle, Scooter, Electric Scooter, Golf Cart, Go Cart, Play Vehicle, Toy Vehicle or any other such motor vehicle or vehicle, on any part of a sidewalk, walking or recreational trail, Ashwaubenon Park or any Village owned property except as otherwise allowed by state law or this Chapter.
- (B) No person shall operate or ride upon any Motor-bicycle, Electric Personal Assistive Mobility Device, All-Terrain or Utility Vehicle, Commercial Quadricycle, Scooter, Golf Cart, Go Cart, Play Vehicle, Toy Vehicle or any other such motor vehicle or vehicle that is not registered for use on Highways with the Wisconsin Department of Motor Vehicles, on any highway, roadway, or street within the Village of Ashwaubenon except as otherwise allowed by state law or this Chapter.
- (C) No parent, guardian or person responsible for the care of any child (16 and under) shall authorize or permit such child to violate this ordinance.

**THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON DOES ORDAIN THAT SECTION 7-270 DEFINITIONS BE AMENDED TO READ AS FOLLOWS:**

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Bicycle*, as defined in Wis. Stats. § 340.01 (5).

*Electric bicycle*, as defined in Wis. Stats. § 340.01 (15ph).

*Electric personal assistive mobility device*, as defined in Wis. Stats. § 340.01 (15pm).

*Electric scooter*, as defined in Wis. Stats. § 340.01 (15ps).

#### **THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON DOES ORDAIN THAT SECTION 7-277 OPERATION BE AMENDED TO READ AS FOLLOWS:**

- (A) No person shall operate a bicycle in the village without the consent of the registered owner.
- (B) Every license issued hereunder shall be deemed to be granted, subject to the following conditions:
  - (1) Every person propelling or riding a bicycle upon a public roadway shall be subject to the provisions of all ordinances and state laws applicable to the operator of any vehicle, except those provisions with reference to equipment of vehicle and except those provisions which by their nature would have no application. Wis. Stats. §§ 346.77 to 346.82, are adopted by reference as part of this section.
  - (2) Every bicycle being operated on public streets or highways in the village between one-half hour after sunset and one-half hour before sunrise must be equipped with a clear headlamp visible for at least 500 feet in front of the bicycle and a clear red light or reflector visible for at least 300 feet to the rear. In addition, every bicycle shall be equipped with a bell or similar device which shall sound a reasonable warning to the other users of the highway.
  - (3) Bicycles will be allowed to be ridden on public sidewalks within the village, provided the operator of a bicycle upon the sidewalk shall yield the right-of-way to any pedestrian and shall exercise due care and give an audible signal when passing a bicycle rider or pedestrian proceeding in the same direction.
