**RESOLUTION APPROVING THE VILLAGE OF ASHWAUBENON WATER UTILITY  
TO CREATE AN EFFECTIVE DATE FOR THE PURCHASED WATER ADJUSTMENT  
CLAUSE**

**WHEREAS**, the Trustees of the Village of Ashwaubenon, Brown County, Wisconsin, are committed to providing safe and reliable water to all residents, businesses, and visitors; and

**WHEREAS**, Public Service Commission (PSC) regulates the Ashwaubenon Water Utility and establishes tariff sheets for the Water Utility; the tariff sheets were revised as part of the most recent conventional water rate case (4/26/2023); and

**WHEREAS**, the tariff sheets allows for a Purchased Water Adjustment Clause, this Purchased Water Clause allows for a pass through of rate increases from Green Bay Water to the residents and businesses of Ashwaubenon; and

**WHEREAS**, in spring of 2023 the Village adjusted its water rates through a conventional rate case; at this time the rates were adjusted to allow for the revenues to align with the expenditures from the utility; and

**WHEREAS**, on August 1, 2024 Green Bay Water Utility adjusted its rates 17%; the Village using the Purchased Water Adjustment Clause would increase all volume rates to the residents by \$0.43/1,000 gallons; and

**WHEREAS**, rates will be adjusted as follows:

Ashwaubenon

First 100,000 gallons used each quarter: \$5.13 per 1,000 gallons

Next 300,000 gallons used each quarter: \$4.98 per 1,000 gallons

Over 400,000 gallons used each quarter: \$4.88 per 1,000 gallons

Hobart

Volume Charge: \$5.40 per 1,000 gallons

**WHEREAS**, on January 22, 2025 the Public Service Commission issued its final decision and the Utility needs to complete a “Rate Implementation Letter” to establish an effective date; and
