

**ORDINANCE NO. 08-1-25**

**AN ORDINANCE ADOPTING THE VILLAGE OF ASHWAUBENON 2025  
COMPREHENSIVE PLAN**

**WHEREAS**, Sections 62.23(2) and (3), Wisconsin Statutes authorize the Village of Ashwaubenon to adopt a comprehensive plan as defined in Section 66.1001(1)(a) and 66.1001(2) Wisconsin Statutes; and

**WHEREAS**, the Ashwaubenon Village Board adopted written procedures designed to foster public participation in every stage of the preparation of its comprehensive plan update as required under Section 66.1001(4)(a), Wisconsin Statutes; and

**WHEREAS**, the Village of Ashwaubenon Plan Commission adopted, by majority vote, a resolution recommending Village Board adoption of the document entitled “Village of Ashwaubenon 2025 Comprehensive Plan; and

**WHEREAS**, the Village of Ashwaubenon 2025 Comprehensive Plan includes maps and other descriptive materials relating to the nine required elements of a comprehensive plan under Section 66.1001(2) Wisconsin Statutes; and

**WHEREAS**, public meetings were held to obtain public input throughout development of the comprehensive plan in 2024 and 2025, and these meetings included a Village-wide visioning session, monthly Plan Commission meetings, Class 1 public notice with minimum 30-day review period prior to public hearing, and a formal public hearing held on August 26<sup>th</sup>, 2025.

**NOW, THEREFORE**, the Village of Ashwaubenon Board of Trustees, does hereby, by adopting this ordinance, adopt the document entitled “Village of Ashwaubenon 2025 Comprehensive Plan” pursuant to Section 66.1001(4)(c) Wisconsin Statutes.
