### RESOLUTION APPROVING THE VILLAGE OF ASHWAUBENON WATER UTILITY TO INCREASE WATER RATES USING A SIMPLIFIED RATE CASE

**WHEREAS,** the Trustees of the Village of Ashwaubenon, Brown County, Wisconsin, are committed to providing safe and reliable water to all residents, businesses, and visitors; and

WHEREAS, Public Service Commission (PSC) of Wisconsin regulates the Ashwaubenon Water Utility and establishes tariff sheets for the Water Utility; the tariff sheets were revised as part of the most Purchased Water Adjustment Clause (3/18/2025); and

**WHEREAS**, the Public Service Commission of Wisconsin considers a simplified rate case increase only at the request of the Utility; and

WHEREAS, a Simplified Rate Case is a simplified, expedited process for certain eligible municipal water utilities to get smaller, more frequent rate increases to keep up with inflation and rising costs; this process is simpler and less expensive than a conventional rate case and requires a customer notice but does not involve a public hearing; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Village Board of Trustees of the Village of Ashwaubenon shall direct staff to work with PSC to determine if the water utility is eligible for a Simplified Rate Case.
