ORDINANCE NO. 08-1-26

AN ORDINANCE AMENDING THE OFFICIAL FLOODPLAIN ZONING MAP AND ORDINANCE OF THE VILLAGE OF ASHWAUBENON, BROWN COUNTY, WISCONSIN

WHEREAS, the Village of Ashwaubenon has heretofore adopted a Floodplain Zoning Map and Ordinance under the authority of §61.35, §62.23, and §87.30 Wis. Stats.; and;

WHEREAS, the Village of Ashwaubenon has adopted Chapter 14 Floodplain in accordance with requirements of participation in the National Flood Insurance Program; and

WHEREAS, Chapter 14 Floodplain Article 8 of the Ashwaubenon Municipal Code contains a process to amend the floodplain zoning district boundaries; and

WHEREAS, the Federal Emergency Management Agency (FEMA) has approved Letters of Map Revision (LOMR) number 23-05-0990P-550600 effective September 25, 2023; and 26-05-0922P-550600 effective September 28, 2026; and

WHEREAS, the approved Letters of Map Revision (LOMR) need to be amended into Chapter 14 Floodplain of the Ashwaubenon Municipal Code; and

WHEREAS, the Village Clerk has published a Class II notice of public hearing regarding such proposed floodplain zoning change, and a public hearing had been held at the Village Hall on August 25, 2026 at 5:30 p.m. whereupon the Village Board has heard all interested persons, and/or their agents and attorneys; and

NOW THEREFORE, after considering the recommendation of the Plan Commission, and testimony received at the Public Hearing on August 25, 2026, the Village Board of the Village of Ashwaubenon, Brown County, Wisconsin, does hereby amend the Village of Ashwaubenon Floodplain Zoning Map and Ordinance to include LOMR numbers 23-05-0990P-550600 effective September 25, 2023; and 26-05-0922P-550600 effective September 28, 2026 as attached hereto and made part hereof.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall take effect upon its adoption and publication.

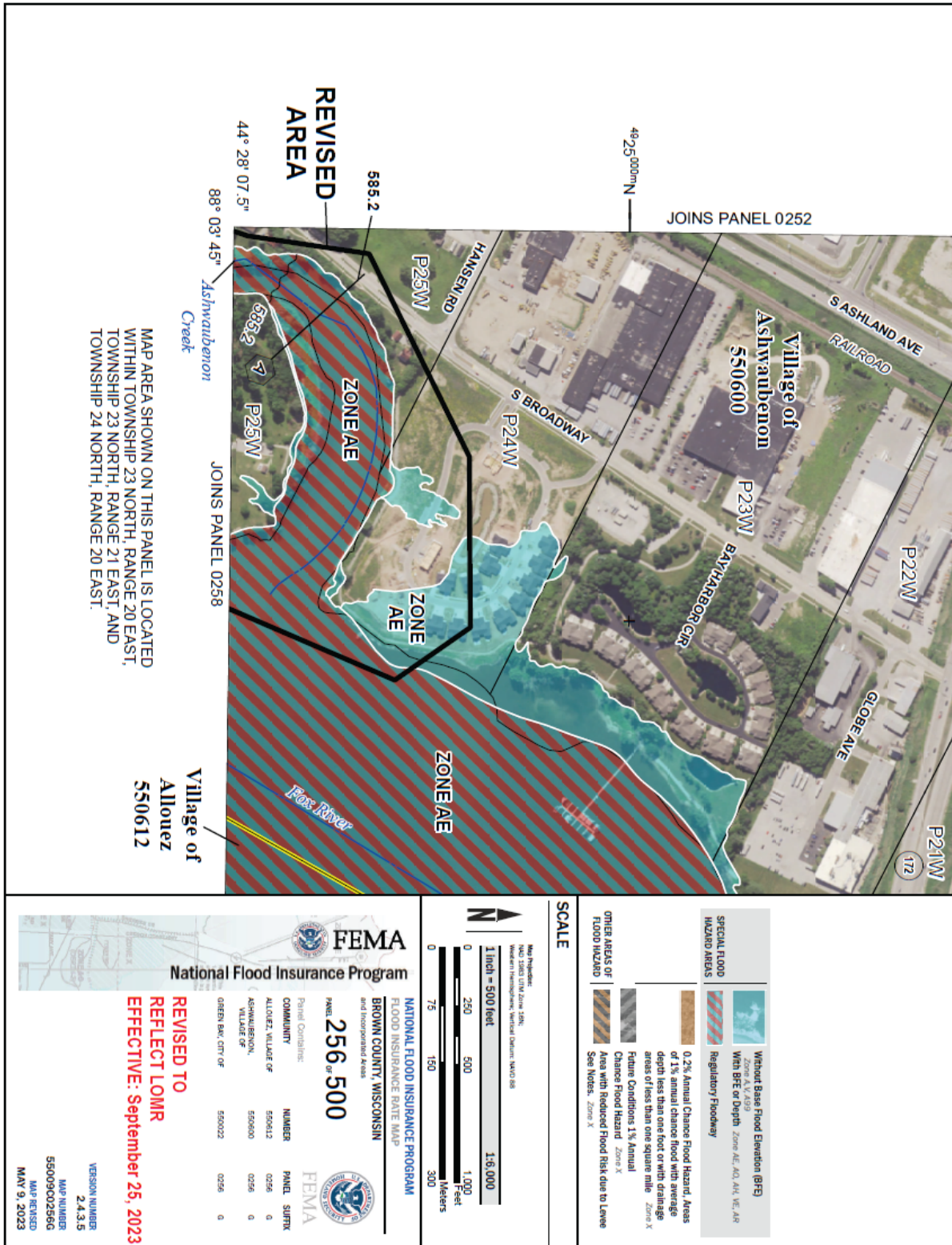

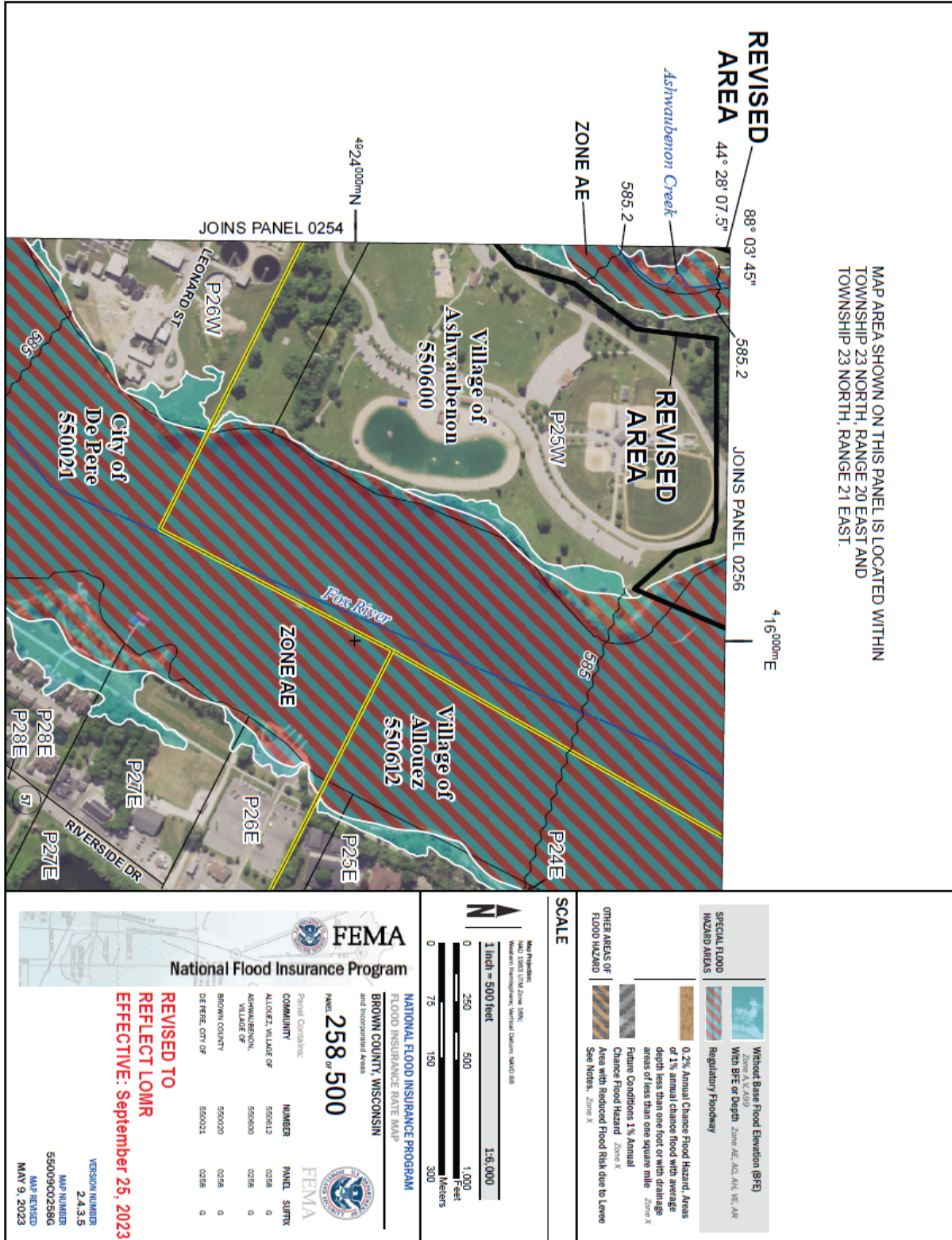
