**WHEREAS**, it is necessary to levy a property tax in the amount of \$15,089,145 to fund the expenses of Village government as contained in the 2026 Annual Budget; and

**WHEREAS**, the Board of Trustees of the Village of Ashwaubenon voted, \_\_ in favor and \_\_ opposed, to approve the 2025 tax levy of \$15,089,145 to be paid in 2026.

**NOW, THEREFORE, BE IT RESOLVED**, by the Village Board of the Village of Ashwaubenon, Brown County, Wisconsin as follows:

- 1. That the 2026 Annual Budget of which is attached hereto and made a part hereof, be and is hereby approved.
- 2. That the property tax is hereby levied and placed upon the 2025 tax roll as follows: \$15,089,145.
