# RESOLUTION AUTHORIZING THE REDEMPTION OF CERTAIN OF THE GENERAL OBLIGATION PROMISSORY NOTES, DATED JUNE 13, 2017

WHEREAS, the Village of Ashwaubenon, Brown County, Wisconsin (the "Village") has outstanding its General Obligation Promissory Notes, dated June 13, 2017 (the "2017 Notes"); and

WHEREAS, the Village Board has determined that it is necessary and desirable to call a \$30,000 portion of the 2026 maturity and a \$30,000 portion of the 2027 maturity of the 2017 Notes for redemption on September 26, 2025 with funds of the Village on hand.

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Village, that a \$30,000 portion of the 2026 maturity and a \$30,000 portion of the 2027 maturity of the 2017 Notes are called for prior payment on September 26, 2025 at the price of par plus accrued interest to the date of redemption.

The Village hereby directs the Village Clerk to work with Associated Trust Company, National Association to cause timely notice of redemption, in substantially the form attached hereto as <a href="Exhibit A">Exhibit A</a> and incorporated herein by this reference (the "Notice"), to be provided at the times, to the parties and in the manner set forth on the Notice. Further, the Village Clerk shall cause the funds necessary to redeem the above-referenced portion of the 2017 Notes to be provided to The Depository Trust Company.
