

Kimberly Street Culvert Replacement Project (Between Glen Rd and Buffalo St)

Project Information: The project replaces the large, corrugated metal culvert pipe that is located under Kimberly St between Glen Rd. and Buffalo St. with a new reinforced concrete pipe. The portion of corrugated metal pipe that is located outside the road right of way will be removed and restored back to an open ditch. To complete this work storm sewer main, and watermain work will be completed as some portions are in conflict with the culvert installation. There may be a short timeframe when water service is shut off, but notifications will be sent out prior to any shut offs occurring. Construction is anticipated to begin on September 15th with a tentative completion of Mid-October, weather dependent.

Anticipated Timeline: Construction, September 15th, 2025 – Mid October 2025

Road Closures, Vehicles & Traffic: While under construction, Kimberly St. will be closed between Glen Rd. and Buffalo St. Residents that live on this portion of Kimberly St. will have access to their home but will only have access from the side of the culvert they live on. The designed detour route is to have traffic bypass the road closure using Buffalo St. to Balsam Way to Glen Rd. and vice versa.

Resident Access: Local resident access to and from your home will be maintained as much as possible. Please let the Project Inspector or the Contractor know of any special provisions that may be needed to help you access your property.

Communication: It is the intent of the Village to minimize the amount of disruption and inconvenience to the community during any construction process. If during normal work hours you feel something went unnoticed, or needs attention, please contact **Matt Smith**. As project inspector, he is most familiar with the daily operations of construction and can resolve many issues quickly.

If something happens after normal work hours that you feel requires immediate attention, please call 920-492-2995, and arrangements will be made to resolve the issue. As always, in an emergency, please call 911. Additional information is available on the Village website.

Project Updates: Construction updates will be posted on the Village website bi-weekly, and when major changes will be occurring. If at any time you would like additional information, please contact any of the contacts listed on this page.

General Notes:

1. The Village is coordinating with mail carrier, and garbage/recycling pickup to ensure deliveries and pickups will not be affected by construction.
2. Please remove any irrigation, electric pet fences, landscaping, and other items within the Right-of-Way. This is your responsibility and not the Villages.

Two Week Anticipated Outlook:

Week of 9/8/25: Dynamic message board signs are to be installed on each end of the job site to inform drivers of the road closure taking place the following week.

Week of 9/15/25: The contractor, De Groot Inc, is scheduled to arrive on site. Tree removal and brush trimming is to take place this week along with erosion control being installed. Once the tree clearing and brush removal is complete Degroot is scheduled to start removing the old culvert from the conservancy area and re-establish the creek through the conservancy..
