BY THE VILLAGE BOARD OF THE VILLAGE OF ASHWAUBENON:

Claim of: Kyle Corrigan  
Date of Loss: May 3, 2025

WHEREAS, a Notice of Claim has been filed against the Village of Ashwaubenon by the above claimant as outlined in the attached Claim identified and incorporated herein as Exhibit A; and

WHEREAS, the Claimant, Kyle Corrigan, seeks monetary compensation for alleged Constitutional violations, emotional and psychological harm, attorney's fees and other relief available under federal and state law; and

WHEREAS, the Notice of Claim has been reviewed by Village Staff and representatives of the League of Wisconsin Municipalities Mutual Insurance, which make a recommendation for the disallowance of such claim; and

NOW THEREFORE BE IT RESOLVED that the above claim against the Village of Ashwaubenon be, and the same is hereby, disallowed.

BE IT FURTHER RESOLVED that, upon disallowance by the Village Board, the Village Clerk shall notify the claimant of such disallowance. Notification shall be in writing, by registered or certified mail return receipt requested, pursuant to Wisconsin Statute Section 893.80(1g). The notice shall contain the following language:

No action under this claim may be brought against the Village of Ashwaubenon, its subdivisions, officers, officials, agents, or employees after 6 months from the date of service by certified or registered mail that the claim is disallowed pursuant to Section 893.80(1g) of the Wisconsin Statutes.
