A RESOLUTION REQUIRING THE REPAIR OF AN AT-GRADE CROSSING

WHEREAS, Hansen Road, Pilgrim Way, Potts Avenue, and Cormier Road, are public streets in the Village of Ashwaubenon crossing the tracks of the Canadian National Railroad at-grade, and

WHEREAS, section 86.12 of the Wisconsin statutes requires railroads to maintain public atgrade crossings is in good condition and repair for public travel, and

WHEREAS, the Hansen Road, Pilgrim Way, Potts Avenue, and Cormier Road crossings are not in good condition and repair for public travel due to loose steel rails and deteriorated wooden ties, and

WHEREAS, the Village of Ashwaubenon hereby requires that the Canadian National Railroad pave, plank, repair, change or otherwise improve the crossing, as the needs require, and

NOW, THEREFORE, BE IT RESOLVED, that the Ashwaubenon Village Board of Trustees hereby directs the Ashwaubenon staff to serve a copy of this resolution upon the Canadian National Railroad requiring the railroad to repair the rail-highway crossings Hansen Road, Pilgrim Way, Potts Avenue, and Cormier Road with the tracks of the Canadian National Railroad in the Village of Ashwaubenon, Brown County, Wisconsin.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that in the event that the Canadian National Railroad fails to repair the rail-highway crossing within 30 days after service of the resolution, the Village Board of Trustees hereby directs Ashwaubenon staff to take all necessary steps to petition the Office of the Commissioner of Railroads for an investigation and order for the repair of the rail-highway crossings of Hansen Road, Pilgrim Way, Potts Avenue, and Cormier Road with the tracks of the Canadian National Railroad in the Village of Ashwaubenon, Brown County.
